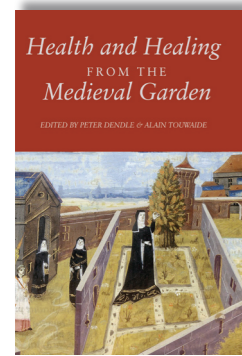

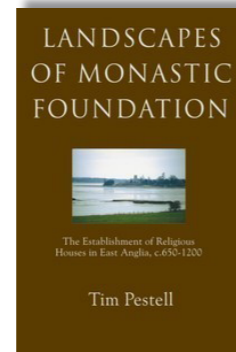

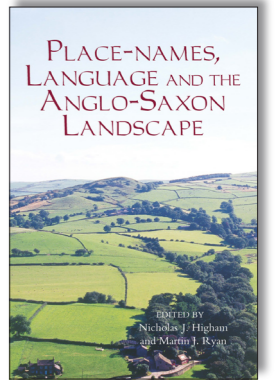

The landscape of modern England still bears the imprint of its Anglo-Saxon past. Villages and towns, fields, woods and forests, parishes and shires, all shed light on the enduring impact of the Anglo-Saxons. These essays explore the richness of the interactions between the Anglo-Saxons and their landscape: how they understood, described, and exploited the environments of which they were a part. Ranging from the earliest settlement period through to the urban expansion of late Anglo-Saxon England, the book draws on evidence from place-names, written sources, and the landscape itself to provide fresh insights into the topic. Subjects include the history of the study of place-names and the Anglo-Saxon landscape; landscapes of particular regions and the exploitation of particular types; the transmission and survival of written sources; and the problems and potentials of interdisciplinary research into the Anglo-Saxon landscape.

NICHOLAS J. HIGHAM is Professor of Early Medieval and Landscape History at the University of Manchester; MARTIN RYAN lectures in Medieval History at the University of Manchester.

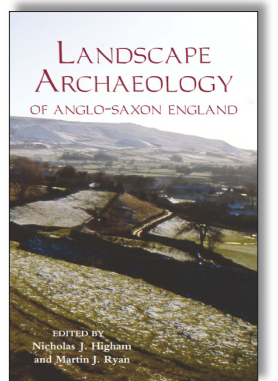
THE LANDSCAPE ARCHAEOLOGY OF ANGLO-SAXON ENGLAND

Traditional opinion has perceived the Anglo-Saxons as creating an entirely new landscape from scratch in the fifth and sixth centuries AD, cutting down woodland, bringing with them the practice of open field agriculture, and establishing villages. Whilst recent scholarship has proved this simplistic picture wanting, it has also raised many questions about the nature of landscape development at the time, the changing nature of systems of land management, and strategies for settlement. With topics ranging from the impact of coppicing to medieval field systems, from the representation of the landscape in manuscripts to cereal production and the type of bread the population preferred, these essays offer striking new approaches to the central issues of landscape change across the seven centuries of Anglo-Saxon England, a period surely foundational to the rural landscape of today.

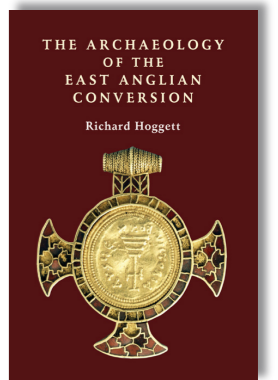
THE ARCHAEOLOGY OF THE EAST ANGLIAN CONVERSION

RICHARD HOGGETT

The conversion to Christianity of the Anglo-Saxon kingdom of East Anglia left huge marks on the area, both metaphorical and literal. Drawing both on the surviving documentary sources, and on the eastern region's rich archaeological record, this book presents the first multi-disciplinary synthesis of the process. It begins with an analysis of the historical framework, followed by an examination of the archaeological evidence for the establishment of missionary stations within the region's ruinous Roman forts and earthwork enclosures. The conversion can also be seen in the dramatic upheavals which occurred in the East Anglian landscape, including changes in the relationship between settlements and cemeteries, and the foundation of a number of different types of Christian cemetery. Ultimately, it shows that far from being the preserve of kings, the East Anglian conversion was widespread at a grassroots level, changing the nature of the Anglo-Saxon landscape forever.

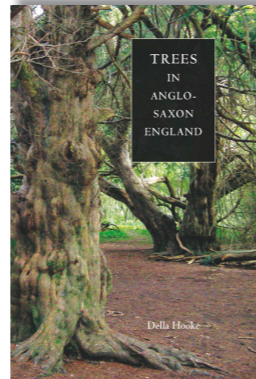
Trees played a particularly important part in the rural economy of Anglo-Saxon England, both for wood and timber and as a wood-pasture resource, with hunting gaining a growing cultural role. But they are also powerful icons in many pre-Christian religions, with a degree of tree symbolism found in Christian scripture too. This wide-ranging book explores both the real historical and archaeological evidence of trees and woodland, and as they are depicted in Anglo-Saxon literature and legend.

Changing Landscapes, 1870-1950

SUSANNA WADE MARTINS & TOM WILLIAMSON



This book investigates how the landscape of East Anglia developed in the period of the so-called great depression, beginning in 1870, and the phase of wartime intensification which succeeded it after 1930. It considers how fields, farms and villages developed in this period of dramatic agricultural change; examines the fate of country houses, gardens, and landed estates; and looks in some detail at the character of habitat change – at the development of hedges, woods, wetlands and heaths. It also considers how new kinds of landscape, ranging from vast conifer plantations to holiday resorts, came into existence. The period of the 'great depression' was not simply one of stasis and decay. It was instead a time in which there were fundamental changes in the rural environment, changes which were not always beneficial to wildlife and biodiversity.

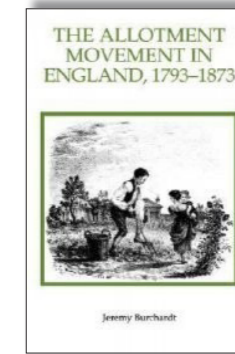

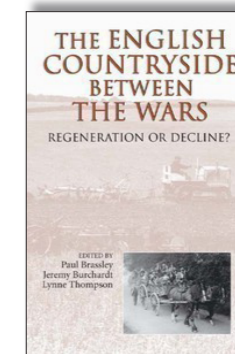
